TRUSTEE'S REPORT

Department Of environmental Protection for NJ is interested in reducing the exposure of dental patients to radiation. They would like to use F speed film instead of D speed film because F speed film results in less radiation to patients. Ideally they would like practices to use digital radiographs. The DEP intends on visiting 400 offices to evaluate their use of x-ray film. They understand that sometimes a D speed film is needed to obtain a more diagnostic radiograph. But in those offices that use D speed film because it costs less they would like to talk with the doctor about using F speed film instead. They are not trying to be punitive. They just want to disseminate information.

Medical Device Tax – It is not a sales tax but a tax on a manufactured item that must be paid by the manufacturer. The problem with the tax is the confusion on what is considered a medical device. It does not pertain to dentures, partials or crowns ordered from a laboratory. It does include any item listed by the FDA as a material for human use. In other words gutta percha, amalgam, noble metal are considered a medical device. Other examples of medical devices are polishing agents, articulating paper, toothbrushes, sterilizers, dental chairs, dental floss, prophy cups, resin tooth bonding agents, performed crowns, implants, implant abutments, impression materials, pit and fissure sealants, bone grafting materials, porcelain teeth, denture reline, orthodontic headgear, ultrasonic scalers, dental burs, dental cements, cavity varnish, dental hand instruments, orthodontic plastic brackets, snoring devices, and extraoral orthodontic headgear. The manufacturer must pay the 2.3% tax. The question is whether the sellers- Paterson, Benco, Darby, or Henry Schein will pass the cost on to the dentist. The complete list of the devices can be found on the web site 21 cfr part 872. 21 refers to the FDA, CFR means Code Federal Regulation, and part 872 means refers to the part of the regulation that deals with devices related to the industry. Go to Google and type in 21 cfr part 872for the list.

The ADA recently published a report dealing with mid level providers. The report stated that midlevel providers are not helping to stem the tide of the caries epidemic nor reducing the population needs for these services. The report did state that if more personnel are treating cavities more cavities get treated but that does nothing to reduce the number of people getting cavities. It goes on to state that appropriately trained midlevel providers are capable of providing high quality services including irreversible procedures such as restorative care and dental extractions. What is less clear is if midlevel providers can provide these services in a cost effective manner and if incorporation of these providers into the workforce will result in improved oral health of the population.

NJDA is exploring whether or not to consider backing a change in the dental law to allow for expanded duty dental assistants. At the present time the NJDA has assembled a task force to look into this. I can tell you right now that this is a contentious issue with the Board Of Trustees.
