Mercer Trustee Report, Sep. 2023 BOT Meeting Highlights Dr. Janhavi Rane

- NJDA Budget presented and approved by BOT. Will now go to Delegates meeting in November to be approved.
- Peer Review Program was reviewed....should be a member benefit and non-members will be charged possibly an annual membership fee.
- NJDA's Council on Peer Review is responsible for oversight and administration of the system, while local peer review committees conduct the actual review. The council is composed of a chairman and one member from each of the twelve component dental societies, as well as each of the specialty societies. The council's duties include setting policy standards for the individual peer review committees and earing appeals of the committee decisions. Administrative duties involved with each case are performed by the council staff at the NJDA headquarters. Each component society has a peer review committee to review cases involving general dentists in its component area. Disputes concerning specialists are referred to the appropriate committee.

- The Compact Act was voted in favor of by BOT, will be presented to Delegates in Nov.
 Navigating the various state licensing requirements, rules, regulations and fee structures can
 present significant challenges for workers. To address these challenges, states and professions
 have turned to occupational licensure interstate compacts. These compacts create reciprocal
 professional licensing practices between states, while ensuring the quality and safety of
 services and safeguarding state sovereignty. To date, over 40 states and territories have
 adopted occupational licensure compacts for nurses, physicians, physical therapists,
 emergency medical technicians and psychologists.
- If the dentist or dental hygienist meets the requirements set forth in the compact (CODA degree, national boards, clinical exam, background check, any required jurisprudence), they are authorized to obtain compact privileges in any other compact state. There is no process whereby the remote states can "block" a licensee from practicing in their state if they meet all of the eligibility criteria.

Medicaid Report

NJ Family Care currently has over 2.3 million enrollees. During the Public Health Emergency, states could not disenroll Medicaid participants. Since the end of the COVID-19 PHE, NJ has been working to re-credential and re-enroll all eligible participants. All children regardless of immigration status are eligible if they qualify financially.

The ADA is promoting the idea of more dentists seeing Medicaid patients and increasing the capacity of those dentists already seeing the participants. They have chosen 6 states for a pilot project. The states selected are Pennsylvania, Nebraska, Rhode Island, Maryland, South Dakota and Ohio. Dr. Whitman expressed his concern over Medicaid reimbursement rates.

<u>Legislative & Regulatory</u>

The NJDA Dept. of Governmental and Public Affairs is focused on the upcoming NJ November elections. 120 NJ legislative seats are up for reelection. 30 of these seats have no incumbent running, making 2023 the largest change in legislators since 1991.



Several bills have been proposed. Bill A4913 requires payers to offer health care providers reimbursement by all reasonably available methods of payment. This legislation is focuses on payment methodology as a whole, rather than only a Virtual Credit Card. Another bill prohibits carriers from preluding dentists from billing a covered person under certain circumstances. Another bill would authorize health care providers to negotiate with carriers regarding fee and non- fee related matters. One of the features of the bill will allow for dentists to negotiate jointly under state oversight from the Attorney General.

New ADA claim forms were introduced. The major change of note is the area for locum tenants' doctor information. You need to contact each company.

A discussion took place concerning the ADA's new Third- Party Payer Concierge. There was a discussion concerning the need for to have someone at NJDA who members can discuss dental benefit issues with.NJDA discussed the option to facilitate and coordinate a series of dental benefit FAQs and/or a podcast/webinar. Medical Loss Ratio was discussed as it relates to dentistry.

The first order to business was electing the President Elect of the ADA. This individual is not yet the president but will be in one year. During that year period he or she learns the duties of the president. The House elected Brett Kessler from Colorado. The other two candidates were Craig Armstrong for Texas and Susan Doroshow from Illinois. The interesting thing about these three candidates was there stand on Medicare. Armstrong strongly opposed any participation of dentistry in Medicare. Susan Doroshow felt that we owed it to the people who do not have dental coverage and are 65 and older to include dentistry with Medicare. Brett Kessler felt that we should wait to first see what the government would pay for procedures before making any decisions.



The second order of business was voting for the second Vice President. Once again this individual will not be Vice President until next year. Dr. Edwin del Valle-Sepulveda from our own 4th district won the contest.

The third order of business was voting on over 100 resolutions that were presented to the House of Delegates. Listed below are the resolutions that the House of Delegates spent a lot of time discussing.

Resolution 201: Comprehensive Policy on Dental Licensure:

This resolution had multiple parts but two parts that were contentious. The first part involved establishing provisions for freedom of movement across states lines for all dental professionals to provide quality oral health care for the public. This resolution was being driven by the Department of Defense. The DOD was concerned that when personnel are transferred to another state, the spouse who is a dentist, is unable to practice in that state. This resolution would support the formation of licensure compacts between state dental societies and state dental boards. If your state is a member of the compact and you would like to move to another state in the compact and practice dentistry you would be allowed to do this if you were an individual member of the compact. You would have to pay a fee for this privilege. On the other hand if you have no intention on moving to another state you would not have to join the compact and therefore there would be no fee. Individual state boards of dentistry would not lose any power under this program and incoming dentist would have to abide by the rules of that state. An advantage to the concept is that any disciplinary action of a dentist by another state in the compact would be available to all states in the compact. The discussion on this resolution involved concern over the power of individual state boards of dentistry. Also on there was concern in the cost of setting up these compacts. Lastly some dentists felt that this resolution would be helping dentists in DSO organizations rather than dentist in individual practices.

The second part of this resolution involved eliminating of patients in the clinical examination required for licensure. The reason involved ethical and psychometric concerns. Needless to say some delegates were concerned with not requiring dental students to work on real life patients.

The House voted to refer this resolution back to committee for further review.

Resolution 305: To allow payment for dental services for medically compromised individual under Medicare when the dental procedure is intrinsically linked and integral to the health outcomes of the covered medical procedure:

An example of how this resolution would be applied is that if a patient 65 or over needs to have a knee replaced and dental clearance is required and this dental clearance requires certain dental services, payment for these services would be provided by Medicare. Dental CDT codes would be used along with dental claim forms when submitting to Medicare. The reimbursement rate would be such that 80% of the dentists within each geographic area receive their full fee.

At face value this resolution seems to be good idea for dentistry. Unfortunately some delegates myself included expressed concern with the resolution. I told the house that once the government establishes a reimbursement value for a dental procedure what is to stop insurance companies from using the same reimbursement value. Considering Medicaid's level of reimbursement for dental procedures I felt that the Medicare level of reimbursement would not be at the fair market value. Individuals responded to this statement by saying we need to keep our seat at the table when the government is discussing dental coverage with Medicare and this resolution allows for this to happen. I responded that I did not feel we would be looking at a seat but instead we would be the main meal. After some extensive discussion the house decided to adopt this resolution.
